McKinleyville Municipal Advisory Committee

The MMAC is comprised of eight voting members and one alternate who reside, own property, or conduct a business in the greater McKinleyville area. The MMAC is tasked with gathering input from the community and commenting on matters of concern which relate to county services provided to the greater McKinleyville area including but not limited to public works, health, safety, welfare and public financing. A secondary responsibility of the MMAC is to review, comment and provide advisory recommendations to the Planning Commission and the Board of Supervisors on proposed zoning amendments, and general plan petitions and amendments located within the McKinleyville planning area related to conformance with the McKinleyville community plan. The MMAC will also discuss and provide input on long-range planning issues.
